Use this form to apply for an owner-builder certificate in accordance with Section 48E of the *Building Act* 1993.

When completing this form <u>all</u> registered owners of the property where the building works will be undertaken, must be included. If there are more than 2 owners, please photocopy this page and attach to the application.

To register as an owner-builder you must:

- Be a natural person/s (including natural person as trustees) and the registered owner/s of the property. Note: A company, a Trust or any other entity can **NOT** apply for an owner-builder certificate.
- Be completing the following "prescribed building work":
  - Work over the value of \$12,000 for, or in connection with, the construction of the following:
    - a) Class 1a single detached dwelling (new house); or
    - b) Class 10 building (e.g. a carport or shed) attached to the house and built at the same time as the house; or
    - c) Retaining walls (whenever constructed) related to the structural integrity of the house.

The constructions of new duplexes/townhouses (Class 1a or Class 2 flats/units) or extensions to these buildings over \$12,000 cannot be undertaken by an owner-builder and <u>MUST BE</u> undertaken by a Registered Building Contractor.
